Trustees & Finance Teams are made up of the Chair and the two Elected Representatives. The Chair may include others to be on the team when they meet as the team; however those chosen by Chairs may not sit on Administrative Ministry Team. Ex-officio members on each of the Administrative Teams are AM Team Coordinator and AM Leader, the Church Council Chair and Pastor. They are to have voice and vote except where the Discipline says Pastor may not have vote.

Because all the elected persons are represented at the meeting of the Administrative Ministry Team they may make decisions on any administrative matters before them, unless "The Discipline" states otherwise. However, if the chair of the originating committee feels a decision should be tabled until their committee meets again then the final decision should be left to the next Administrative Ministry Team or the next Church Council Meeting whichever comes first.
